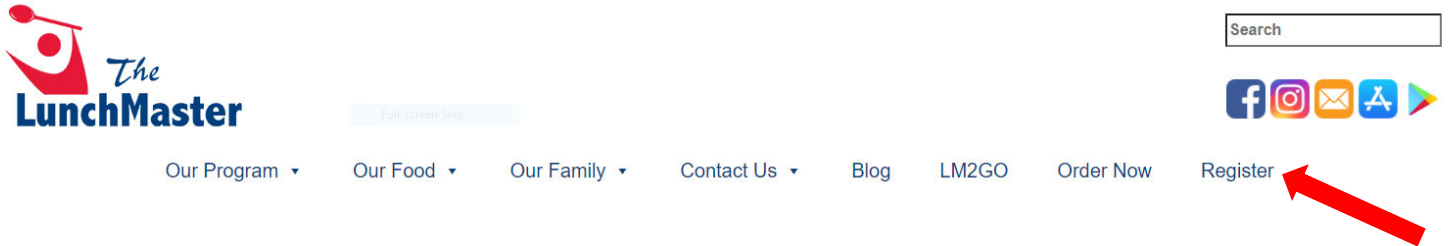


Cómo Crear una Cuenta & Ordenar en Línea
